
Abnormal Result Follow up: EDU

Nurse discusses with patient tests required for EDU process and confirms how patient will receive results and how patient wishes to be contacted with positive results.

Nurse documents contact details for positive results, such as correct mobile, email and also whether GP can be contacted for any positive results. This is documented in the comment box on RCP.



A) Chlamydia +ve or Trichomonas +ve

EDU result dr call and text patient x3 EDU nurse tried to contact px x3

Patient has a regular GP, who EDU have consent to contact. GP contacted via phone, informed of positive result and asked to follow up EDU discharge letter amended to note patient uncontactable re positive result and GP contacted to follow up .Result box has comment positive chlamydia trichomonas patient uncontactable

Patient does not have a regular GP.. Result box has comment patient positive chlamydia / trichomonas patient uncontactable

B) N Gonnorhoea +ve

EDU result dr call and text px x3 EDU nurse tried to contact px x3

Patient has a regular GP, who EDU have consent to contact. GP contacted via phone, informed of positive result and asked to follow up EDU discharge letter amended to note patient uncontactable re positive result and GP contacted to follow up. Result box has comment positive N Gonnorhoea patient uncontactable referred sexual health

Patient does not have a regular GP. Result box has comment positive N Gonnorhoea patient uncontactable

Nurse refers to sexual health

C) Positive syphilis

EDU result dr call and text patient x3

Patient has a regular GP, who EDU have consent to contact. GP contacted via phone, informed of positive result and asked of any other ways to contact px.

EDU result dr discusses with sexual health nurse regarding follow up and follow up deferred to sexual health..EDU discharge letter amended to notes px positive syphilis and sexual health to follow up

Patient does not have a regular GP. Result box has comment patient uncontactable and result doctor has referred to Sexual health nurse to follow up

D) Abnormal ultrasound result

_EDU result dr call and text patient x3Edu nurse tries to contact x3

Patient has a regular GP, who EDU have consent to contact .GP contacted via phone, informed of positive result and asked to follow up. EDU discharge letter amended to note patient uncontactable re positive result.GP to follow up Result box has comment patient uncontactable for GP follow up

Patient does not have a regular GP. Result box has comment patient abnormal scan uncontactable

E) Abnormal blood result

EDU Nurses call and text patient

Patient has a regular GP, who EDU have consent to contact. GP contacted via phone, informed of abnormal result and asked to follow up .EDU discharge letter amended to note patient uncontactable re positive result and GP requested to follow up . Result box has comment abnormal result patient uncontactable for GP follow up

Patient does not have a regular GP. Result box has comment on abnormal result patient uncontactable
